DIRECTIONS FOR USE

Growing Media Preparation and Production – For use in containers, pots, hanging baskets, flats, trays and plugs. Mix H2PRO with water prior to application. Incorporate or drench mixture into growing media.

GENERAL INFORMATION

H2Pro is a residual wetting agent that remains in the media to allow water to re-wet the particles. Stable in growing media in storage. Excellent Initial wetting and long term wetting. Excellent through wetting/drying cycles. Flexible, compatible and easy to use. Mixes easily even at very low temperatures. There may be variations in longevity under variable growing conditions.
