## SECTION 4 - FIRST AID MEASURES

**IF IN EYES:** Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control center or doctor for treatment advice.

**ENVIRONMENTAL SUMMARY:** This pesticide is toxic to marine/estuarine invertebrates. Do not apply directly to water, to areas where surface water is present or to intertidal areas below the mean high water mark. Drift and runoff may be hazardous to terrestrial and aquatic plants in neighboring areas. Do not contaminate water when disposing of equipment washwaters or rinsate.

**FATE:** Sulfentrazone is highly persistent with a half life of 3-18 months depending on soil type and weather conditions. It is very mobile in certain soil types with potential to contaminate ground water,
