**Response:**

**If inhaled:** Remove person to fresh air and keep comfortable for breathing. Call Poison Control Center or Doctor if you feel unwell.  
**If on skin:** Wash with plenty of water while removing contaminated clothing and shoes. Get medical attention if symptoms occur. Wash clothing before reuse. Destroy contaminated leather items such as shoes, belts, and watchbands.  
**If in eyes:** Hold eye open and rinse slowly and gently with water for 15 to 20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eyes for at least 10 minutes. Obtain medical attention without delay, preferably from an ophthalmologist

**Storage:**

Store in a cool, dry, well ventilated, and secure area designated specifically for pesticides and away from heat sources.

**Section 4: First-Aid Measures**

**Eye Contact:** Hold eye open and rinse slowly and gently with water for 15 to 20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eyes for at least 10 minutes. Obtain medical attention without delay, preferably from an ophthalmologist.

**If Swallowed:** Call a poison control center or doctor immediately for treatment advice. Rinse mouth with water then have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by the poison control center or doctor. Do not give anything by mouth to an unconscious person. Have product label with you when calling a poison control center or doctor.

**Skin Contact:** Immediately flush skin with water while removing contaminated clothing and shoes. Get medical attention if symptoms occur. Wash clothing before reuse. Destroy contaminated leather items such as shoes, belts, and watchbands.

**If Inhaled:** Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably mouth-to-mouth, if possible. Call a poison control center or doctor for further treatment advice.

**Note to Physician:** There is no specific antidote if this product is ingested. Treat symptomatically.

## Section 5: Fire Fighting Measures

**Fire Hazards:** Closed containers may rupture if exposed to excess heat or flame due to a build-up of internal pressure. Thermal decomposition during a fire can produce fumes and irritating gases.

**Flammability classification (OSHA 29 CFR 1910.1200):** Non-combustible

**Fire Fighting Procedures:** Keep people away. Isolate fire and deny unnecessary entry. Evacuate the area and fight the fire from upwind at a safe distance to avoid hazardous vapors or decomposition products. Dike and collect fire-extinguishing water to prevent environmental damage and excessive waste runoff.

**Firefighting media:** Use foam, dry chemical, carbon dioxide, or water fog when fighting fires involving this product. Do not use water jet, as this may spread burning material. Minimize the use of water to avoid environmental contamination. Contain all runoff.

**Special Protective Equipment for Firefighters:** Wear positive-pressure self-contained breathing apparatus (SCBA) and protective firefighting clothing (includes firefighting helmet, coat, trousers, boots, and gloves). Use full face shield and operate in positive pressure mode. Avoid contact with this material during firefighting operations. If contact is likely, change to full chemical resistant firefighting clothing with self-contained breathing apparatus. If this is not available, wear full chemical resistant clothing with self-contained breathing apparatus and fight fire from a remote location. ## Section 6: Accidental Release Measures

### Steps to be taken if Material is Released or Spilled:

- Contain spilled material if possible. Small spills: Apply a suitable absorbent and sweep up. Collect in suitable and properly labeled containers. Large spills: Contact Drexel Chemical Co. for clean-up assistance. See Section 13, Disposal Considerations, for additional information.

### Personal Precautions:

- Isolate area. Keep unnecessary and unprotected personnel from entering the area. Refer to Section 7, Handling, for additional precautionary measures. Spilled material may cause a slipping hazard. ## Section 7: Handling and Storage

### KEEP OUT OF REACH OF CHILDREN

**Handling:** **General Handling:** Avoid contact with eyes, skin, and clothing. Wash thoroughly after handling. Do not swallow. Avoid breathing vapor. Use with adequate ventilation. Wear chemical protective equipment when handling. Keep away from heat, sparks and flame. See Section 8, Exposure Controls and Personal Protection.

**Storage:** Store in a cool, dry, ventilated and secure area designated specifically for pesticides and away from heat sources. Keep in original containers and keep containers closed when not in use. Do not store in excessive heat. Do not store near children, food, foodstuffs, drugs or potable water supplies.

## Section 8: Exposure Controls / Personal Protection

**Exposure Limits:** TLV Mono/dibasic Sodium, Potassium, and Ammonium Phosphite Mixture 5mg/m<sup>3</sup>

### Personal Protection:

**Eye/Face Protection:** Wear safety glasses with side shields or chemical splash goggles to prevent vapors or mists from entering the eyes. If using a full face shield, always use safety glasses or goggles along with the face shield to ensure adequate protection of the eyes.

**Skin Protection:** To avoid contact with skin, wear long pants, long-sleeved shirt, socks, shoes and chemical resistant gloves. Safety shower should be located in immediate work area. Remove contaminated clothing immediately after use, wash skin area with soap and water, and launder clothing before reuse or dispose of properly. Items which cannot be decontaminated, such as shoes, belts and watchbands, should be removed and disposed of properly.

**Hand protection:** Use gloves chemically resistant to this material. Examples of preferred glove barrier materials include: Neoprene, Nitrile/butadiene rubber ("nitrile" or "NBR") or Polyvinyl chloride ("PVC" or "vinyl").

**Respiratory Protection:** Respiratory protection should be worn when there is a potential to exceed the exposure limit requirements or guidelines. When handling in enclosed areas, when large quantities of mists are generated or prolonged exposure is possible in excess of the TLV, use a respirator with either an organic vapor-removing cartridge with a prefilter approved for pesticides (MSHA/NIOSH approval number prefix TC-23C) or a canister approved for pesticides (MSHA/NIOSH approval number prefix TC-14G).

**Ingestion:** Avoid ingestion of even very small amounts; do not consume or store food or tobacco in the work area; wash hands and face before smoking or eating.

**Engineering Controls:**

**Ventilation:** When handling this product proper ventilation is required to maintain exposure below the TLV. Ventilate all transport vehicles prior to unloading. Facilities storing or utilizing this material should be equipped with and eyewash facility and safety shower.

**Stability/Instability:** Thermally stable at typical use temperatures and in closed containers.

**Conditions to Avoid:** Avoid heat of open flame. Avoid high temperatures above 130°F (54.4°C).

**Incompatible Materials:** Avoid contact with: Strong oxidizers, strong reducers and water reacting materials.

**ENVIRONMENTAL FATE:**

- Studies show that phosphorus acid is not harmful to most non-target organisms and of low toxicity to fish and aquatic invertebrates.

**Persistence and Degradability:**

- Phosphorus acid and its salts are rapidly dissociated in the environment to yield hydrogen and phosphate ions. Over time, the phosphate ions can be taken up by plants as various salts, transformed to different oxidation states, or bound with other substances in soil.
