## LAKE AND POND COLORANT

### GENERAL INFORMATION

Tired, off color water in lakes, ponds and other controlled source aquascapes will be restored to a natural reflective luster with easy to use, non-toxic Aqua Black Select pond dye. Aqua Black SELECT creates a dark mirror-like surface while reducing sunlight penetration. Aqua Black SELECT will not interrupt recreational activities or irrigation schedules. It is safe for aquatic life, waterfowl, and pet sand will not stain swimwear, stone, or other ornamental features when applied as directed below.

### DIRECTIONS FOR USE

Pour the recommended rate of Aqua Black SELECT in several areas around the shoreline and allow windblown currents and temperature differences to diffuse the colorant throughout the water feature or pour directly into mechanical circulation equipment for faster dispersal.

Use the following formula to determine the appropriate volume of water for treatment:

Pond Length (ft.) x Pond Width (ft.) x Average Depth (ft.) 43,560 ft. (acre foot = 325,851 gallons water)

### APPLICATION RATE

1 acre of water average depth approximately 4 feet - 1 gallon of dye

Smaller water features approximately 8500 gallons - 1 ounce of dye

Sunlight, biological processes, precipitation dilution and chlorine will gradually diminish the color intensity. Reapply Aqua Black SELECT every 2-4 weeks as needed to maintain the reflective quality of the water surface. Aqua Black SELECT should be used in confined water systems only and not in rivers or streams.

### STORAGE AND DISPOSAL

Storage: Store in a cool, dry place. Store in original container only. Do not add anything to the container. Keep container tightly sealed when not in use. Do not store near fire, flame or other potential sources of ignition. Do not contaminate water, food or feed by storage or disposal of this product.

Disposal: Do not reuse empty container. Triple rinse (or equivalent) during mixing and loading. Recycling decontaminated containers is the best option of container disposal if allowed by law. Decontaminated containers and materials must be disposed of in a manner allowed by local, state and federal laws and regulations
