Recommended application modes: foliar spray, fertigation injection, or drip irrigation.

## TURF APPLICATION RATE

Apply MIKROPAK™ at 2.5 pounds (2 scoops) to 5 pounds (4 scoops) per acre bi-weekly. Increase/decrease rate accordingly to frequency of application. Apply only to actively growing turf.

## DECORATIVE PLANTS RATE

Apply MIKROPAK™ at 0.50 ounce to 1 ounce per 1000 square feet for color, growth or remedial action on plants.
