## 4. FIRST AID MEASURES

---

## 6. ACCIDENTAL RELEASE MEASURES

---

In Case of Spill: Evacuate the spill area, except for cleanup personnel. Wear NIOSH/MSHA-approved respirator and protective equipment. Control spill with adsorbent pads or booms. Recover free liquid. For recovery or disposal, add inert absorbent (sand, earth, sawdust, etc.) to spill area and shovel into containers for disposal. Product is slippery under foot; flush smooth surfaces thoroughly. ## 7. HANDLING AND STORAGE

---

Keep away from heat, sparks and flame. Keep container closed. Avoid direct or prolonged contact with skin or eyes. Wear appropriate equipment and clothing to prevent repeated or prolonged skin contact as referenced in Section 8 below. Use in areas with adequate mechanical exhaust ventilation, or wear respirator. Product should be stored in a dry area with temperatures above 32°F (0°C). Partially used containers should be resealed between uses for maximum storage stability.

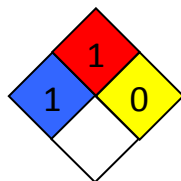
