4. FIRST AID MEASURES

Have the product container or label with you when calling a poison control center or doctor, or going for treatment. For chemical emergency: spill, leak, fire, exposure or accident, call CHEMTREC: 1-800-424-9300.

5. FIREFIGHTING MEASURES

Flame Extension: > 23 in.

Fire and Explosion Hazards: Aerosol container contains flammable gas under pressure, risk of explosion when exposed to excessive temperatures. Thermal decomposition may generate irritating and possibly toxic gases.

Extinguishing Medium: Foam, dry chemical, or carbon dioxide (CO₂).

Fire Fighting Equipment: Firefighters should be equipped with self-contained positive pressure breathing apparatus and full bunker gear.

Fire Fighting Instructions: Evacuate area of all unnecessary personnel and fight fire from a safe distance upwind. 6. ACCIDENTAL RELEASE MEASURES

Personal Precautions: Isolate area and keep unnecessary and unprotected personnel from entering. Extinguish nearby and downwind sources of ignition. Ensure adequate ventilation. Wear suitable personal protective clothing and equipment as described in Section 8 of this document.

Environmental Precautions: Prevent material from entering public sewer systems or any waterways. Do not flush to drain or soil. Contain contaminated water.

Spill Cleanup: Stop the source of the release and clean up spill immediately. Contain and isolate to prevent further release into soil and water. Absorb spill with absorbent material (such as clay, sand, or dirt) and place in suitable container for disposal. Wash spill area with water and pick up wash liquid with additional absorbent and place in container for disposal.

7. HANDLING AND STORAGE

Handling: Do not get in eyes or on clothing. Wash hands before eating, drinking, chewing gum, using tobacco, or using the toilet. Remove clothing immediately if pesticide gets inside. Then wash thoroughly and put on clean clothing. Remove personal protective equipment (PPE) immediately after handling this product. Wash the outside of gloves before removing.
