## Total Release Foggers

A unique ULV pesticide application system that efficiently delivers about 1.5 billion 10-20 micron-sized particles of active ingredient per unit in minutes. These particles are free of water and inert materials typically associated with other application methods that can contribute to disease and/or phytotoxicity problems. Total release foggers insure uniform coverage with multiple delivery points throughout the greenhouse. The active ingredient is filtered onto the top and bottom leaf surfaces as it circulates throughout the greenhouse on natural air currents. **Pyrethrum TR** can be space-mixed with **Preclude**®, **1300 Orthene**®, **Duraplex**® TR or **Tame**®/ **Orthene TR**. When using **Pyrethrum TR** with another total release insecticide, the most restrictive label applies.

**Pyrethrum TR** cannot be combined with other total release products if applying to vegetables and herbs.
